# THE MARDI LOWRY MCDONOUGH '87 STUDENT OPPORTUNITY FUND & GRANT PROGRAM

Contributions to this fund—named in memory of State High graduate and longtime teacher Mardi McDonough upon her passing in 2020—are the mainstay of the Education Foundation's partnership with generous donors. Funds are awarded to teachers, coaches and staff for projects and programs that benefit students in all grades across the district.

Grant awards have supported a wide range of innovative efforts, from purchasing biographies for a classroom library to helping start State High's Unified Bocce Team. Thanks to donor support, students have had virtual visits from authors and in-person experiences with traveling science labs. Classrooms are outfitted with STEAM equipment, new sensory spaces are available and there's even a student support closet offering clothing and personal care items to students in need.

#### MARDI LOWRY MCDONOUGH, December 26, 1968 - June 1, 2020

In 2020, the State College community lost a wonderful teacher and a dear friend who made a difference in the lives of countless students and her fellow educators. Mardi Lowry McDonough passed away June 1, 2020, following a battle with breast cancer. In partnership with her family, the Education Foundation honored her memory by adding her name to the Student Opportunity Fund & Grant Program. A lifelong resident of State College, Mardi graduated from State High in 1987. She spent her 27 years in the State College Area School District teaching 6th

grade Math, English and Science, starting at Ferguson Township Elementary and then at Park Forest Middle School. Mardi's daughters are



also State High graduates.

Mardi is survived by her husband, Nick Downs, and two daughters, Colleen Eireann McDonough and Grace Aine McDonough, all of State College; step-daughter, Sierra Downs of Boston, MA; father, Lee Lowry of State College and mother, Carol Spangler of Huntingdon, PA. Also survived by her brother, Eric Lowry (Dr. Marta Villaraga) and nieces, Sofia and Isabela of Ardmore, PA.

# MENTAL HEALTH MATTERS FUND

Together with donors and the SCASD student services team, the Education Foundation pioneered the Mental Health Matters Fund in



2019, raising its first contributions, totaling \$50,000, at the Maroon & Gray Society Banquet. The fund continued to thrive as donors recognized the need to focus on student mental health and saw their funds making a difference in measurable ways.

The fund has continued to evolve and fuel an important and innovative support system for students and families that not only addresses mental health programs, but also provides emergency support for basic needs items—an effort that took shape during the COVID-19 pandemic. Community generosity for these efforts has continued to grow, allowing the district to do more.

 A \$25,000 investment from the Education Foundation enabled the district to form a beneficial partnership with Penn State's Herr Clinic, improving and expediting access to mental health services for students and families.

# THE CAMPAIGN FOR MEMORIAL FIELD

MILESTONE \$1 MILLION COMMITMENT FROM LARRY BEANS '62 ADDS TO \$500K PLEDGE FROM GALEN DREIBLELBIS AND ANONYMOUS PLEDGE FOR \$200K

It's been sixty years since Larry M. Beans '62 walked out onto Memorial Field as a quarterback for State High, but he said that the memory of Friday night football remains one of the most vivid memories of his life. "The crisp air, the lights, cheerleaders, the band, people in the stands—it was magnificent."

When he read about the project to renovate the field in the Education Foundation magazine, it resonated with him right away. "I want to see that it's saved and stays in the location where it was originally built. It's a beautiful, iconic setting, and I felt that this was something as a community and as alumni that we can do. I support many causes, but this one is very personal and worthwhile to me," he said.

Larry has pledged a \$1 million gift to the Campaign for Memorial Field. Larry's commitment adds to an anonymous \$200,000 pledge to name the main home team locker room and a \$500,000 pledge from Galen Dreibelbis to name the stadium plaza area near the entry way at Nittany Avenue.

The first part of Larry's commitment, \$875,000, was approved by the school board in May. As part of his gift, Larry has chosen naming rights for the concession stand, the press box, the bleachers and the scoreboard. The concession stand will be named to honor Larry's entire 1962 graduating class. "My teammates were very important to me then, as they are now. I think it's important that all of my classmates are included," he said.

Renovations to Memorial Field will strengthen the foundation for a secure and sustainable future for State College athletics and contribute to State College as a whole. The project improves and increases the safety of the practice and playing experience for athletes, members of the marching



band and community youth sports organizations; leverages the existing structure of the Fairmount Building to add needed indoor space for team meetings; provides an exemplary community gathering space for games and other events by offering a safe, more enjoyable spectator experience; and showcases our students and the tremendous level of community support afforded to our district by engaged and invested local individuals, families and businesses.

- Faculty and staff receive ongoing professional development that helps them to recognize students in crisis and also contributes to an overall culture that prioritizes mental health and well-being.
- Local mental health professionals participate regularly with student services teams at each

school in the district, elevating the level of attention on this issue.

• Families facing financial strain can complete an assessment to receive emergency assistance in the form of grocery store gift cards and help with utility and housing payments. Director of Student Services Jeanne Knouse explains that the impact is simple, yet profound:

"If their basic needs and mental health needs aren't met, students can't learn. With your support for Mental Health Matters, we remove those barriers to learning."

## RENEWED SUPPORT FROM EITC DONORS KEEPS PROGRAMS GROWING

When the Education Foundation was launched, a main priority was securing funds through the Education Improvement Tax Credit program. This state-operated program, known as EITC, dedicates tax credits to individuals and businesses who make contributions to qualifying 501(c)3 organizations.

While the program is most often associated with providing scholarships to low-income families for private school tuition, a portion of EITC funds are dedicated to Education Improvement Organizations or EIOs organizations working to provide innovative programming to students. The Education Foundation qualifies for the program as an EIO, and offers a way for individuals and businesses to keep their state tax dollars in local public schools.

The foundation continues to steward individuals and businesses to support its existing EITC-funded programs:

 Materials and equipment needed for new K-5 STEM curriculum, which is based on the resource Engineering is Elementary, the premier resource for introducing engineering at the elementary level. In addition to drawing from EiE, the district is developing learning experiences that include robotics and coding, along with alignment to grade level science and mathematics.  Computer programming courses at the high school level offered through Oracle Academy, a globally-focused computer science education curriculum that gives students access to courses and resources that would not have been possible without the partnership.

Both individuals and businesses can apply to donate through EITC, as long as they have PA tax liability and meet a few criteria, but currently the tax credits available for Education Improvement Organizations are fully subscribed, and no additional credits have been approved.

It's important to note that existing donors can renew their support, and that credits do become available when donors drop out of the program. While you may be placed on a waiting list, it's still worthwhile to apply.


